Elected to Cabinet in May 2015 to Young People and Children's Wellbeing, 38,001 children in the area with 300+ that need looking after, budget has a vast overspend, Children's and Young Peoples Plan is a County Plan, School Transport causes controversy due to pupils only being bussed to the nearest school, 99 School Buildings with repairs/rebuilds needed using capital investment strategy, 47 Farm Small Holdings to be sold off, Herefordshire City Library has asbestos problems which need addressing, BT has completed a vast amount of Broadband fibre-optic installations and the Core Strategy has at last been adopted enabling the emerging Neighbourhood Development Plans to be completed.
